ITEM: 1

The Members of the **Executive Council** considered in detail the **recommendations / minutes** along with **AGENDA** of the **53**rd **Academic Council** held on 15.03.2024 at 3.00 PM and **approved** as under as indicated against each:

3(1) TO CONSIDER UPLOADING ANTI RAGGING ORIENTATION PROGRAM REPORTS FOR THE SESSIONS 2021-22, 2022-23, 2023-24 ON NEW ANTI RAGGING MODULE OF DCI WHICH IS OPERATIONAL FROM 11.09.2023 ONWARDS AS PER DCI CIRCULARS DATED 11.09.2023 & 19.09.2023

The Members of the **Executive Council** considered the Minutes / recommendations of **Academic Council** for uploading Anti Ragging Orientation Program Reports for the Sessions 2021-22, 2022-23 and 2023-24 on the <u>new Anti Ragging Module of DCI</u> and **noted** the following:

- 1.1 That DCI vide their letter No. DCI/ARPM/ARC/Gen/167/2023-24/2023/3877 dated 11.09.2023 has Notified that the newly designed Anti Ragging Online Module has become operational and directed for uploading Anti Ragging Orientation Program Reports and Anti Ragging Reports of April and October Months every year from April 2023 onwards.
- 1.2 That DCI vide their letter No. DCI/ARPM/ARC/Gen/167/2023-24/2023/4187 dated 19.09.2023 issued a Corrigendum by modifying the word "from April 2023" to "from now onwards".
- 1.3 That the above two DCI Notifications indicates that all reports related to Anti Ragging to be uploaded on DCI's New Anti Ragging Online Module w.e.f 19.09.2023 onwards.
- 1.4 That the Santosh Dental College & Hospital had already conducted Anti Ragging Orientation Programmes for the Academic Sessions 2021-22, 2022-23 and 2023-24 on 03.09.2022, 27.05.2023 and 07.03.2024 respectively and now the same will be uploaded in the DCI Anti Ragging Module according to directions of the DCI.

The members of the **Executive Council** after detailed discussion **approved** as under:

"To upload all Reports of Santosh Dental College & Hospital related to Anti Ragging Orientation Program and Biannual Anti Ragging Reports (April and October) every year may also be uploaded on the newly operational Anti Ragging Online Module of the DCI with immediate effect"

3(2) TO COMPILE TEACHING SCHEDULES FOR BDS 1ST YEAR, 2ND YEAR, 3RD YEAR AND FINAL YEAR FOR THE ACADEMIC SESSION 2024-25 AT SANTOSH DENTAL COLLEGE & HOSPITAL

The Members of the **Executive Council** considered the **Minutes / recommendations** of **Academic Council** for compiling teaching schedules for BDS 1st, 2nd, 3rd and Final Year and **approved the same** for printing and providing to the students and concerned department's faculty for the new sessions starting **tentatively** in August / September 2024, November 2024 and February 2025.

3(3) TO CONDUCT EXTRA CLASSES FOR BDS 2ND YEAR STUDENTS OF 2022-23
BATCH DURING SUMMER VACATION FROM 25.05.2024 TO 24.06.2024
TO COMPENSATE SHORT ATTEDANCES

The Members of the **Executive Council** considered the Minutes / recommendations of **Academic Council** and **approved** the same as under:

- 1. To conduct **extra classes** for **BDS 2**nd **Year students** whose attendance is less than the requirements for appearing University Professional Examinations tentatively will be held in September 2024 during the Summer Vacation tentatively scheduled from 25.05.2024 to 24.06.2024.
- 2. To obtain consent form from each student for attending the proposed extra classes during 25.05.2024 to 24.06.2024.
- 3. It is also recommended that the similar extra classes may be taken for BDS 1st Year, 3rd Year and Final Year students if their attendance is short for appearing University Professional Examinations.

3(4) TO CONDUCT VARIOUS ACADEMIC ACTIVITES REGARDING WORLD ORAL HEATLH DAY CELEBRATIONS ON 20.03.2024 AS PER DCI DIRECTIONS VIDE THEIR LETTER NO. DCI/ARPM/REGULATION/WOHD/GENERAL/DE-242/2024-25/2024/8342 DATED 05.03.2024

The Members of the Executive Council considered the Minutes / recommendations of Academic Council and noted the directions of DCI and MoHFW vide their letters dated 05.03.2024 and 29.02.2024 respectively for conducting various activities for celebration and observance of World Oral Health Day (20.03.2024) to emphasize the importance of Oral Health and educate the masses on the detrimental effects of poor oral hygiene.

The Members of the **Executive Council** after detailed discussion, **approved** the same to conduct the above Academic activities at Santosh Dental College & Hospital.

4(1) TO CONSIDER NMC'S POST GRADUATE MEDICAL EDUCATION REGULATIONS 2023 [PGMER 2023] DATED 29.12.2023 FOR ITS IMPLEMENTATION AT SANTOSH MEDICAL COLLEGE & HOSPTIAL

* * * * *

The Members of the Executive Council considered the Minutes / recommendations of Academic Council for implementation of NMC'S POST GRADUATE MEDICAL EDUCATION REGULATIONS 2023 [PGMER 2023] dated 29.12.2023 from the Batch 2024-25 onwards at Santosh Medical College & Hospital and noted the following:

- That the NMC vide its Notification CDN-19012/5/2023-Coord-NMC dated 29.12.2023 has published the POST GRADUATE MEDICAL EDUCATION REGULATIONS [PGMER], 2023 for its implementation at all Medical Colleges w.e.f. the date of its publication i.e. 29.12.2023.
- 2. It is stated that the NMC vide their Gazette Notification dated 29.12.2023 specially decided in respect of the following besides others:
- 2.1 That Clauses 3.1 and 3.2 of PGMER 2023 regarding Permission and Recognition of PG seats and increase of PG seats states as under:

"3.1 Permission and Recognition

- i. No Medical Institution shall start any post-graduate course unless granted permission from the National Medical Commission or such Board or Boards as indicated by the National Medical Commission.
- ii. Without prejudice to sub-section (i) above, permission to start the post-graduate course in a medical college/institution running the undergraduate course and determination of number of seats to be permitted shall be as per the Establishment of New Medical Institutions, Starting of New Medical Courses, Increase of Seats for Existing Courses and Assessment and Rating Regulations, 2023, Post Graduate Medical Education Regulations, 2023, Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022, MSR(s) notified by UGMEB and PGMEB, Curriculum requirements of respective Speciality as notified/informed from time to time on website or by other methods by Post-Graduate Medical Education Board (PGMEB), other relevant regulations, explanatory notes, circulars and advisories etc., issued from time to time.

The medical college/institution will be permitted to start the post graduate courses if it fulfils all the requirements for running the existing undergraduate course. The medical college/institution can apply for starting the post-graduate course(s) one year after the medical college/institution has been permitted to start an undergraduate course (i.e. during the second year of the undergraduate course).

iii. Existing or proposed non-teaching hospitals owned and managed by government can start post-graduate courses without having undergraduate college, provided they fulfil the norms and procedures prescribed in the Establishment of New Medical Institution, Starting of New Medical Courses, Increase of Seats for Existing Courses and Assessment and Rating Regulations, 2023, Post Graduate Medical Education Regulations, 2023, Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022, MSR notified by PGMEB (PGMSR-23), Curriculum requirements of respective Speciality as notified/informed from time to time on website or

by other methods by Post-Graduate Medical Education Board (PGMEB), other relevant regulations, explanatory notes, circulars and advisories etc., issued from time to time.

iv. Once permitted, the course for the qualification will be considered recognized and seats permitted will be considered as recognized seats for registration of the degree awarded.

Medical colleges/Institutions running such courses will be considered as Accredited Medical colleges/Institutions for the said course of qualification.

3.2 Increase of Seats

Procedures, methods and criteria for increase of seats will be the same as prescribed in sub-section 3.1 above. Provided an increase of seats so granted in already Recognized (Accredited) post-graduate courses shall be deemed to be recognized post-graduate seats for the purpose of registration of the students"

In the above clause, now the NMC once permitted (LoP) for PG seats to start the new courses, the said course / PG Seats for the qualification will be considered as Recognized and seats permitted will be considered as recognized seats for registration of the degree awarded. Similarly, for increase of PG seats once permitted /LoP shall be deemed to be recognized seats.

- **2.2** That Clause 4.7 of PGMER 2023 regarding Students **Migration** states as under:
 - **"4.7 Student Migration No student finally designated to a medical institution,** notwithstanding anything stated in these Regulations, **shall be permitted migration** to any other medical institution."
- 2.3 That Clauses 5.2 (xii) and 5.2 (xiii) of PGMER 2023 regarding training programme i.e. Course in Ethics and Course in Cardiac Life Support Skills states as under:

"5.2 (xii) Course in Ethics

a. All post-graduate students shall complete course in ethics including Good Clinical Practices and Good Laboratory

- Practices, whichever is relevant to them, to be conducted by institutions/Universities.
- b. The students are expected to complete the course in the <u>first</u> year.
- c. No post-graduate student shall be permitted to appear in the examination without the above certification.

5.2(xiii) Course in Cardiac Life Support Skills

- a. All post-graduate students shall complete a course in Basic Cardiac Life Support (BCLS) and Advanced Cardiac Life Support (ACLS) skills to be conducted by the institution.
- b. The students are expected to complete the course in the <u>first</u> year.
- c. No post-graduate student shall be permitted to appear in the examination without the above certification."

The Members of the Executive Council also noted that the above two courses i.e. Course in Ethics and Course in Cardiac Life Support Skills (BCLS) have already been considered and approved by the Academic Council and Board of Management in their meetings held on 24.03.2022 and 30.03.2022 and implemented from the Batch 2021-22 (started from 1st April 2022 in view of COVID).

All PG students admitted from 2021 and after will have to complete the *Advanced Cardiac Life Support (ACLS)* course also **before appearing in the examination**.

Besides these two courses the following have **already** been implemented at Santosh Medical College & Hospital, the details thereof are as under:

- 1) BCBR implemented from the Batch 2020-21 according to the NMC directions
- 2) PG CBME Syllabus from the Batch 2021-22 as approved by Academic Council and Board of Management in its meetings held on 11.06.2021 and 16.06.2021 respectively
- 3) DRP Posting from the Batch 2021-22 as approved by Academic Council and Board of Management in its meetings held on 22.02.2023 and 25.02.2023 respectively.

2.4 That Clause 8.3(A) of PGMER 2023 regarding **Examinations Methodology for Broad Specialties** and Clause 8.4 regarding valuation states as under:

"8.3 Methodology

- A. Broad Specialties: Doctor of Medicine (M.D.)/Master of Surgery (M.S.): M.D./M.S. examinations, in any subject shall consist of theory papers, and clinical/practical and viva voce examinations.
 - a. Theory: The theory examination (both formative and summative) may be of descriptive answer of a question type, Multiple Choice Question (MCQ) type or mix of both types. Theory examination for summative examination shall be of four theory papers. The first and the fourth paper shall be on basic medical science and recent advances, respectively.

The theory examination shall be held well in advance before the clinical and practical examination.

b. Clinical/Practical and viva voce

- i. Clinical examination for the subjects in clinical sciences shall be conducted to test the knowledge and competence of the candidates for undertaking independent work as a consultant/specialist/teacher, for which candidates shall be examined for one long case and two short cases.
- ii. Practical examination for other subjects shall be conducted to test the knowledge and competence of the candidates for making valid and relevant observations based on the experimental/ laboratory studies and his ability to perform such studies as are relevant to his subject.
- iii. The viva voce examination shall be thorough and shall aim at assessing the candidate's knowledge and competence about the subject, investigative procedures, therapeutic technique and other aspects of the Speciality.
- iv. Clinical/practical examination shall include Objective Structured Clinical Examination (OSCE).

8.4 Valuation inter-alia, the Criteria for Evaluation of M.S. /M.D. / M.Ch./ D.M. Courses states as under:

- **2.5** That Clause 10.2 of PGMER 2023 regarding **Animal Experimentation** states as under:
 - **"10.2 Animal Experimentation:** Animal experimentation should continue to be included as an integral part of the competency-based curriculum of post-graduate courses in Physiology and Pharmacology in medical institutions.

However, the use of non-animal, human relevant methods may be encouraged for teaching and training of post-graduate students in these subjects, wherever possible. If animals are used as a part of research studies or thesis work, biomedical ethics and relevant rules and guidelines framed under the Prevention of Cruelty to Animals Act, 1960, must be strictly adhered to."

The members of the Executive Council after detailed discussion, approved the above Clauses 3.1, 3.2, 4.7, 8.3(A), 8.4 and 10.2 of NMC PGMER 2023 for its implementation with immediate effect and Advanced Cardiac Life Support (ACLS) Course for its implementation at Santosh Medical College & Hospital from the Batch 2021 onwards.

The Clauses **5.2(xii)**, **5.2(xiii)** (BCLS) of NMC PGMER 2023 (29.12.2023) have already been approved by Academic Council and Board of Management and implemented from Batch 2021-22 onwards.

4(2) TO CONSIDER NMC'S POST GRADUATE MINIMUM STANDARD REQUIREMENTS REGULATIONS 2023 [PGMSR 2023] DATED 15.01.2024 FOR ITS IMPLEMENTATION AT SANTOSH MEDICAL COLLEGE & HOSPTIAL –PG SEATS AND FACULTY REQUIREMENTS

The Members of the Executive Council considered the Minutes / recommendations of Academic Council for implementation of NMC'S POST GRADUATE MINIMUM STANDARD REQUIREMENTS REGULATIONS 2023 [PGMSR 2023] dated 15.01.2024 from the Batch 2024-25 onwards at Santosh Medical College & Hospital and noted the following:

- 1.1That the National Medical Commission (NMC) vide their Notification No. P016(11)/1/2023-PGMEB-NMC(part-1) dated 15.01.2024 has issued Guidelines for NMC'S POST GRADUATE MINIMUM STANDARD REQUIREMENTS REGULATIONS 2023 [PGMSR 2023] for its compliance at all Medical Colleges from the date of publication.
- 1.2That as per above NMC Gazette Notification dated 15.01.2024, specially decided in respect of the following besides others:
- 2.1 Clause 3 of PGMSR 2023 regarding Clinical Material / investigation workload requirements states as under:

"3. Clinical material/investigation workload required for postgraduate will be as per **Annexure-I** and as per the curriculum requirement.

Annexure-I QUANTIFICATION OF THE CLINICAL MATERIAL/INVESTIGATION WORKLOAD REQUIRED FOR POST-GRADUATE COURSES IN SPECIALITIES

Clinical material/ investigation workload required for postgraduate courses will be as per curriculum requirement in curriculum documents of each speciality as notified by NMC time to time on website, etc. Following are additional general/specific guidelines.

7. Course Content:

Embalming, in most modern cultures, is the art and science of temporarily preserving human remains to forestall decomposition and make it suitable for display at a funeral. The three goals of embalming are thus preservation, sanitization and presentation (or restoration) of a dead body to achieve this effect.

An advanced course in embalming extends beyond foundational training and certification, providing supplementary expertise and insights that can greatly benefit medical students in diverse ways.

Key Components of a Value Added Course

A value-added course for embalming should cover the following key components:

- 1. **Body and Organ Donation:** Body donation is the donation of the whole body after death for medical education and research. Such donated bodies remain a principal teaching tool for anatomists and medical educators teaching gross anatomy. This act is called "deh dan".
- 2. Evolution of contemporary embalming and restorative art: Embalming is the art and science of temporarily preserving the dead human body. It is aimed at forestalling decomposition to make the body suitable for transportation to the final destination where last rites are to be performed.
- 3. Ancient Egyptians used evisceration and immersion in their special solution. Ancient Sicilians had devised a method that used heat. Arsenic and mercury were popular for a while and currently, arterial injection and cavity treatment with formalin is the normal practice.
- 4. Chemical Embalming- Fluids and procedures
 - Arterial fluid- In this, the fluid is injected into the arterial system. The formalin content may vary a little depending on the type of body to be embalmed, i.e., an autopsied or burnt case etc.
 - Cavity fluid- Here, the embalming fluid is directly injected into the thoracic, abdominal and pelvic cavities.
 - Hypodermic embalming- It is supplemental where the embalming fluid is directly injected into the tissues.
 - Surface embalming- Preservation gels/ fluids are directly applied to the surface as packs/gels.
- 5. **Modified Thiel Embalming Technique-** Through this new procedure, the corpses, tissues and the organs retain their flexibility and plasticity as in a living person. This method results in well preserved organs and tissues concerning colour, consistency, flexibility and plasticity.
- 6. Standard precautions to be observed during embalming and postexposure prophylaxis- The procedure of embalming can expose the embalmers to the risk of acquiring various infectious diseases by any of the following routes:
 - > Percutaneous
 - Contact
 - > Inhalation
 - Ingestion
- 7. Medicolegal aspects of embalming-
 - > Purposes:
 - a. Teaching
 - b. Late arrival of relatives/ Transportation

c. Public display at a funeral

> Types of Bodies

- a. Non MLC cases
- **b.** MLC cases
- c. Known/Claimed
- **d.** Unknown/ Unclaimed

8. Prerequisites

- a) Identification
- b) Consent
- c) Death Certificate
- d) Postmortem report
- e) No objection certificate

In conclusion, an enhanced embalming course is crucial for enriching embalmers' skills and broadening the understanding of medical students. These courses equip embalmers to address the varied needs of deceased individuals' families and enhance the functionality of anatomy labs. Moreover, they significantly contribute to the holistic education of medical students. Investing in continuous embalming education benefits anatomists, students, and embalmers alike, creating a mutually beneficial scenario.

 - d. Establishing and outline an objective, unbiased process for the application, evaluation, approval and disbursement of benevolent assistance.
 - e. Providing eligibility requirements and criteria for receiving assistance for concession.

 - h) Causing disruption in any manner of the functioning of the Institutions under Santosh Deemed to be University.
 - Regarding ragging the directive of Supreme Court will be followed strictly. It is as under:

"As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside of the campus and the Institute authorities are determined not to allow any form of the ragging. Whoever directly or indirectly commits, participates in abets or instigates ragging within or outside any educational Institution, shall be suspended, expelled or restricted from the Institutions and shall also be liable to fined which may extend to Rs. 10,000/Rs. 25,000/-. The punishment may also include cancellation of admission, suspension from attending the classes, withholding / withdrawing fellowship / scholarship and other financial benefits, withholding or cancelling the result. The decision shall be taken by the Head of the Institution".

4. Without prejudice to the generality of his / her powers relating to the maintenance of discipline and taking such action in the interest of

maintaining discipline as may seem to him/her appropriate. The Vice Chancellor, may in exercise of his / her powers aforesaid order or direct that any student or students:

- a) Be expelled;
- b) Be, for a stated period: Be not for a stated period, admitted to a course or courses of study in Institutions under Santosh Deemed to be University.
- c) Be fined with a sum of rupees that may be specified;
- d) Be debarred from taking any examination(s) for one or more semesters.
- e) Withhold the result of the student(s) concerned in the
- f) Examination(s) in which he / she or they have appeared be cancelled.
- g) Be prohibited for appearing or completing any examination for any unfair means like copying, taking notes, mobiles or any other electronic gadgets inside the examination halls.
- 5. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/ herself to the disciplinary jurisdiction of the Vice Chancellor and several authorities of the Institutions under Santosh Deemed to be University who may be vested with the authority to exercise discipline under the Rules, the Statutes, the Regulations and the rules that have been framed there under by competent authorities of Institutions under Santosh Deemed to be University.

1.1.2. PROHIBITION OF RAGGING AND PUNISHMENT

- 1. Ragging in any form is strictly prohibited, within the premises of College/Department of Institution and any part of Institutions under Santosh Deemed to be University and also outside the Institutions under Santosh Deemed to be University Campus.
- 2. Any individual or collective act or practice or ragging constitute gross indiscipline shall be dealt with under the Rules.
- 3. Ragging for the purposes of this rules, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are, in any way, considered junior or inferior by other students and includes individual or collective acts or practice which:
 - a) Involve physical assault or threat or use of physical force;
 - b) Violate the status, dignity and honour of women students;

- c) Violate the status, dignity and honour of students belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Castes.
- d) Expose students to ridicule and contempt and affect their self-esteem;
- e) Entail verbal abuse and aggression, indecent gesture and obscene behaviour.
- 4. The Vice Chancellor, Dean Faculties Medical / Dental, Hostel Warden(s) and Faculty of Institutions under Santosh Deemed to be University shall take immediate action on any information of the occurrence of ragging.
- 5. Notwithstanding anything in Clause (4) above, the Dean(s) or any other Faculty member/or authority may also suo moto enquire into any incident of ragging and make a report to the Vice Chancellor of the identity of those who have engaged and the nature of the incident.
- 6. The Dean may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. On the receipt of a report under clause (5) or (6) or a determination by the relevant authority disclosing the occurrence or ragging incidents described in the Clause 3(a), (b) and (c) the Vice Chancellor shall direct or order rustication of a student or students for a specific number of semester.
- 8. The Vice Chancellor may in other cases of ragging order or direct that any student or students be expelled or be not, for a stated period, admitted to a course of study at Institutions under Santosh Deemed to be University, departmental examination for one or more semesters or that the result of the student or students concerned in the examination(s) in which they appeared be cancelled.
- 9. In case where students who have obtained degree(s) of Santosh Deemed to be University are found guilty under this Rules, appropriate action will be taken for withdrawal of degrees conferred by the Santosh Deemed to be University.
- 10. For the purpose of this Rules, abetment to ragging will also amount to ragging.

1.1.3. <u>PREVENTION, PROHIBITION & REDRESSAL OF SEXUAL HARASSMENT COMMITTEE</u>

As per UGC Norms, a Statutory Committee, comprising of members from the teaching and non-teaching staff as well as students looks into matters related to sexual harassment of students and staff in

the college. Any person aggrieved in this matter may fearlessly approach the Committee for a fair hearing and redressal.

1.1.4. STUDENTS GRIEVANCE COMMITTEE

The students Grievance Committee looks into matters related to the grievances of all Under Graduate and Post Graduate students of Santosh Deemed to be University.

1.1.5. UNAUTHORIZED ABSENCE OF STUDENTS:

Unauthorized absence of students will be informed to the Students and also Parents or Local Guardians. At least 3 reminders will be issued with a gap of 10 days by the Academic Section to these students. Thereafter the action of cancellation of the registration of the concerned will be decided by the Dean(s) / Vice Chancellor, Santosh Deemed to be University.

1.1.6. HOSTEL RULES

APPLICABLE TO BOTH BOYS AND GIRLS:

The residents of the hostel are required to follow the hostel rules strictly as given below:

- 1. Rooms are allotted on the basis of the criteria / procedure laid down by the authorities from time to time. No change will be affected during the continuity of the session.
- 2. The students at the time of admission to the hostel must show the receipt(s) of the hostel fee and room rent paid to the warden to his/her satisfaction and unless and until it is done, the occupancy of any accommodation within the hostel will not be allowed.
- 3. Residents will be held fully responsible for any loss or damage to the electrical fittings, furniture etc. in their room(s).
- 4. Students / Residents are not allowed to use Electrical Heater / or any other electrical apparatus run by power in their respective rooms or elsewhere.
- 5. Students should not keep expensive / gold items in their rooms.
- 6. No student shall permit any stranger / friend / relatives / unauthorized person to live in his/her room even for a short period and if found so, the student shall be liable for serious action against him/her including expulsion from the hostel.
- 7. No female shall be allowed to enter the hostel / rooms except the

- Guest Room in Boy's hostel and Vice Versa for the Girls Hostel.
- 8. All lights and fans must be switched off before leaving the room, failing which fine will be imposed for each item found to be on when the room is locked.
- 9. Residents are required to write their name and his/her mobile No., parent/guardian contact address and their phone/mobile Nos. on the register maintained for the purpose with the Care Taker/Warden before leaving for outstation on the weekends/holidays etc. after obtaining permission.
- 10. No students / residents should be rough with the mess/canteen employees. Any complaints against an employee must be brought to the notice of the Mess Manager and Warden only.
- 11. All the residents are supposed to take their meals at the prescribed time in the mess and not to carry food materials to their rooms.
- 12. None of the residents should create any disturbance or nuisance for the fellow residents by rushing about in the stair cases corridors and playing radios/VCRs/TV/Stereos in the hostel room is strictly prohibited.
- 13. Any student found in possession of or having taken alcoholic drinks or any kind of narcotic/intoxicating drug will be expelled from the hostel.
- 14. Anybody found violating any of the above rules shall render him / her to disciplinary action.
- 15. Discovery of any lethal weapons or arms on the person or in possession of a hostel student, shall invite expulsion from the college.
- 16. The hostel residents shall compulsorily leave / vacate hostel during summer vacation (30 days) and winter vacation (15 days) unless his/her stay is warranted by the college authorities for the examination and or clinical purposes.
- 17. Discovery of involvement of any ragging activity in the hostel or college in any manner either individually or in group on any hostel residents or college students, shall invite expulsion from the college and hostel besides filing F.I.R. with the police.
- 18. Every student before admission to the hostel, shall give an Undertaking that he/she shall not keep any unauthorized person, in his/her room and that if he/she is found keeping such a person he/she shall be liable for disciplinary action.
- 19. No students / residents of the hostel will be absent from the hostel without the written permission of the Warden. Residents wishing to visit friends or relatives allowed by the parents, even on holiday, shall obtain the written permission of the Warden, if the rule is not

- observed by the hosteller, the consequences and responsibilities are entirely of the parents.
- 20. Residents wishing to absent themselves from the hostel after closing time of gate (9.00 PM) except on hospital duty, shall obtain prior permission from the Warden stating where he/she will be going and when they shall be back in the hostel. Permits to leave the hostel may ordinarily be obtained from the Warden between 5.00 pm and 6.00 p.m.
- 21. Illness must be reported to the Warden by the student concerned at once.
- 22. No smoking in the rooms or in the hostel premises.
- 23. The following criminal offences will be forthwith reported to the police and offenders will be handed over to the respective authority:
 - Consumption of drugs.
 - Theft/stealing
 - Vandalism / Destruction of Public Property.
 - Littering & Gambling
 - Unlawful assembly or gathering for the purpose of committing anything illegal.
 - Fighting
 - Any other forms of criminal Act or Behaviour.
- 24. No Members of the opposite sex shall be allowed in rooms.
- 25. No cooking in the room.
- 26. Lights, Fans and Air-conditioning to be switched off when no one is in the room.
- 27. Duplicate of keys is prohibited and unauthorized entry to a room is a serious offence. Trespassers will be seriously dealt with.
- 28. The Management reserves the right to expel students or change their rooms at its own discretion.
- 29. The Management reserves the right for its designees to enter and inspect a residence in the interest of health, safety and proper conduct of the students. Entry can be made at any time, whether or not the students are present and without prior notice to the students, if emergency, health or safety circumstances warrant such entry or if there are reasonable grounds to believe that any substance, material or item is being kept or used on the premises in any manner prohibited by the law or by this Rules.
- 30. Entry by the Management may also be made without prior notice, during normal hours, for the purpose of conducting non-emergency inspections. For repairs and/or for the purpose of showing the

- premises, students will be notified.
- 31. The original receipt shall be surrendered for refund of Hostel Security Deposit.
- 32. Students are expected to attend college on the reopening day after vacation. No excuse will be considered.
- 33. Modern outfits which may distract the attention of others are strictly prohibited.
- 34. Each student must sign the attendance register every day at 9.00 PM. Not presenting and signing the attendance will amount to unauthorized absence from the hostel. The hostel authorities shall not be responsible for the same unless otherwise obtained prior permission from the Hostel Warden or some authorized person.
- 35. No Power consuming Electrical appliance like AC / Heater / Cooler / Micro woven shall be allowed in the hostel room, unless they are permitted by the authorities on payment of prescribed fee. Such payment receipt should be shown to the authorized person before installation.
- 36. Any other matter that is not explicitly stated in these Rules shall be decided by the College / Board of Management.

APPLICABLE FOR GIRLS ONLY:

- 1. Parent / Guardian are expected to produce a list of probable visitors of the student with specimen signature of the probable visitor along with those of their own.
- 2. If parent / Guardian is not able to produce this on admission they are expected to send it soon after.
- 3. Nobody else will be allowed to meet / take her out either from the college or from the Hostel.
- 4. Persons who bring letter from the parent / Guardian or those from the authorized list will only be permitted to meet / take her out.
- 5. Each student will be issued a check out book containing 20 leaves for a whole year. This book will not be reissued and not transferable.
- 6. During holidays Parent / Guardian are expected to accompany or send authorization letters to the College / Hostel Warden, failing which she will not be allowed to leave the hostel.
- 7. The students are expected to reach the hostel within the stipulated time. She must sign the register kept for the purpose on entry which will be checked periodically.
- 8. Outings and shopping must be intimated to the concerned authority or warden and prior permission must be obtained with statement of check out and check in timings failing which disciplinary action

will be taken.

- 9. Authorized female relatives and friends will be allowed to visit the inmates but are not allowed to stay beyond 8.00 PM.
- 10. All hostlers are expected to join the Mess and abide by the rules and regulations of the mess.
- 11. No male relatives will be allowed to enter either class rooms or hostel other than the visitor's room.
- 12. On working days even if the student goes out with prior sanction or permission she is expected to be back on or before 8 PM to the hostel.
- 13. In times of emergency if the Parent / Guardian want the students to visit them, the message must reach college / Hostel through proper channel (telegram / fax).
- 14. All letters for the students may be scrutinized.

1.2. Students Concession

The Santosh Deemed to be University committed for elimination of social stigma laid over the socially and economically disadvantaged, empowering the women community and extending utmost support to the transgender community.

1.2.1. Objectives:

The Fee Waiver cum Reimbursement Policy of Santosh Deemed to be University aims to:

- 1. To put into practice, the vision of our founder and to make higher education accessible to all.
- 2. **Reduce financial barriers:** The University strive to eliminate economic obstacles that may prevent individuals or organizations from accessing our services or participating in our programs.
- 3. **Promote inclusivity:** to create an inclusive environment where everyone, regardless of financial means, can engage fully and contribute meaningfully to our community.
- 4. **Support diversity:** The University acknowledges the diverse needs and circumstances of students, stakeholders and endeavor to accommodate them through flexible fee structures.
- 5. To help students from economically weaker sections pursue higher education and to reach high positions.

1.2.2. Eligibility Criteria:

The eligibility criteria for fee waiver schemes is determined based on factors such as income level, financial need, or specific circumstances such as unemployment, disability, or other compelling situations and the fee waiver programs those targeted towards backward castes and scheduled castes and tribes, can vary depending on the specific program and institution on the following factors:

- Income Level: Many fee waiver schemes consider the income level of applicants or their families. Eligibility may be determined based on criteria such as family income falling below a certain threshold as decided from time to time / as per the other criteria fixed by the University from time to time.
- Caste or Community: Fee Waiver / Reimbursement schemes targeting backward castes, scheduled castes and scheduled tribes belonging to these specific communities as defined by government classifications, after verification of the concerned documents.
- 3. **Merit Criteria:** While socioeconomic factors are often primary considerations, certain fee waiver / Reimbursement schemes may also assess applicants based on academic performance, extracurricular achievements, or other merit-based criteria.

1.2.3. Types of Fees Covered:

The Fee Waiver / Reimbursement Policy of the Santosh Deemed to be University applies to various fees only.

1.2.4. Review and Decision Process:

Fee waiver / Reimbursement applications are reviewed by designated individuals from Finance Section or committees according to established guidelines and criteria. Decisions are made impartially considering the available financial conditions and availability of funds at the said point of time and the same will be communicated to applicants in a timely manner. The percentage of Fee Waiver / Reimbursement consideration of the student's application is depending on the Programme / Course admitted to the University.

1.2.5. Communication and Transparency:

The University committed to ensure transparency and clarity in the fee waiver / reimbursement policy. Information regarding eligibility

criteria, application procedures, and decision-making processes is readily available to all stakeholders.

1.2.6. Review and Revision:

This Fee Waiver / Reimbursement Policy is subject to periodic review and revision to ensure its effectiveness, relevance, and alignment with our organizational values and goals.

1.2.8. Other Terms and Conditions:

1. Multiple concessions can be availed by the student in the year, however the amount of concession / waiver to be considered for these

schemes is subject to change from case to case basis as per their eligibility and as per the availability of funds at the said point of time.

- 2. The scholarship amount / Fee waiver / reimbursement is strictly restricted/calculated only on the Tuition Fees applicable to a Day Scholar / hosteler as per the Fee Structure of the course. All other applicable fees are to be payable by the student.
- 3. The concession is valid only for one academic year. A fresh application with relevant supporting documents will have to be submitted in the subsequent year (if eligible).
- 4. All decisions for the grant of concessions/ waiver are at the sole discretion of the Finance Officer / Committee and no representation will be accepted.
- 5. The concession amount / waiver will be adjusted only against the last instalment(s) as per the fee structure.

1.3. Students Representation

Santosh Deemed to be University acknowledges that students need to be represented equitably and fairly through an independent and accountable organization, and that every student can contribute to the enhancement of their programme and learning experience. The primary aim of student representation at the University is to provide students with an opportunity to voice their views, suggestions and concerns through a proper and efficient process. Student Council is a body of students to promote quality in student life within and outside the University. It is a democratic support system for holistic development of the students and will work in consonance with the respective departments/clubs /groups of the University with their faculty support. The Students Council will report to and will function with the general supervision of the principal or his nominee.

1.4. Student Counselling

The University recognizes that a student may experience problems in coping with issues in their personal lives and in the environment where they live and learn. Counselling services offered to promote and facilitate positive mental, psychological health and emotional wellbeing of students and to enhance the students' academic and personal functioning.

University also maintains the Mentor Mentee program, through which students can share any issues (Academic; Non-Academic; Personal; familial etc.) with their mentor and suggestions to problems may be given to help the students.

1.5. Security

The University takes the security of its students and staff very seriously. The Security Department under the Department of Personnel is committed to protecting its life and wellness. The University takes care on the students security day in and day out through CCTV surveillance at the hotspots.

1.6. CLUBS

Active participation in the Youth Groups and Movements for its are highly encouraged. These aspects give the students opportunities for overall personality and Holistic development. The University has various Clubs and the students can apply for membership for any of the clubs whose selection will be done by the animators of each club/movements after due formalities coordinated by the Dean Student Welfare.

1.7. Student Entertainment

The University holds entertainment events from time to time to keep students entertained and relaxed. The University organizes various co-curricular activities such as debate, speech competition, essay writing contest, elocution, painting, singing, music, drawing, quiz, cricket, football, basketball, volleyball, table tennis, Badminton, etc. University also focuses on celebration of different commemorative days throughout the Year

1.8. International Student Exchange

University always wants to appreciate the good performers in academics and those who have done anything to take the name of the University to different Heights and for the same University send these high flyers to for student exchange in different National & International Universities under different MoUs Signed with those Universities.
