#### **SELECTION METHOD:**

THROUGH ENTRANCE TEST i.e. Paper – 1: MCQ's of **General Aptitude**, Paper-2: MCQ's of **SUBJECT SPECIFIC - [ONLINE MODE]** AND INTERVIEW/VIVA VOCE/PRESENTATION **[ONLINE MODE]**.

#### **TIME LINES: :**

- ✓ Last Date for **ONLINE REGISTRATION** for Entrance – **2<sup>nd</sup> December 2023**.
- ✓ Issue of **online** Hall Tickets for ONLINE WRITTEN EXAMS [INCLUDING ROLL NO, ID AND PASSWORD] – **6<sup>th</sup> December 2023**.
- ✓ Date of ONLINE ENTRANCE EXAMINATION – 10.00 A.M, **8<sup>th</sup> December 2023**.
- ✓ Date of ONLINE INTERVIEW / VIVA VOCE/ PRESENTATION on **11<sup>th</sup> & 12<sup>th</sup> December 2023** - exact date and time will be intimated **only to the candidates appeared and secured 50% marks (aggregate) in the Entrance Test will be eligible for the interview by email**.
- ✓ Declaration of Results – **15<sup>th</sup> December 2023**.
- ✓ Date of Commencement of Ph,D Course – **30<sup>th</sup> December 2023**.

- a. **Paper – 1: MCQ's of General Aptitude**, intended to assess the teaching / research aptitude of the candidate [**35 Marks**].
- b. **Paper-2: MCQ's of subject specific** for the concerned Ph.D. Course [**35 Marks**].
- c. **The students who will secure 50% marks (aggregate) in the Entrance Test will be eligible for the interview by email.**
- d. **Interviews / Viva Voce of Presentation [30 Marks]:**  
The candidates are required to present their **Research Interest / Area** through Power Point presentation before the Department Research Committee of the concerned department during their Interview / Viva Voce.
- e. **Final selection will be based on the merit after combining the marks of entrance test [70%] and interview [30%], separately for each concerned department. [Total = 100 Marks]**
- f. **The selection letter will be issued to selected candidates only by email after the selection procedures are over.**
- g. **The candidates who have passed the CSIR-UGC NET – JRF examination or IRF examination by agencies like ICMR/ Department of Atomic Energy (DAE) etc., or have been selected already for JRF/ SRF/ Project fellows in research projects sanctioned by funding agencies to any of the faculty members of Santosh Deemed to be University shall be exempted from appearing for the Ph.D. entrance examination.**

1. **The Ph.D. course will start from 30<sup>th</sup> December 2023.**

2. Duration of the Course: 3 years (Minimum) and 6 years. (Maximum)

3. Fellowships / Grant / Funding:

**After finalization of the admission process and scrutinization of JRF & SRF Fellowships eligibility, offer letter will be sent to the selected candidates only.**

4. The expenses if any, towards consumable items, shall be borne by the Ph. D student.

5. In case the student is selected for Ph.D. programme and no Fellowship / Grant from a recognized institution / college is available with him/her, in such case the student is required to bear all expenses for the same.
